Master Research Fellowship

The NOVA National School of Public Health, NOVA University Lisbon, has opened an offer position for 1 Research Fellowships(s), within the scope of the R&D project EXPOSIM - Environmental stressors as causal determinants for immune-mediated diseases – mapping and prioritizing evidence for knowledge-based policy-making, call HORIZON-HLTH-2024-ENVHLTH-02-06-two-stage, reference 101156311, funded by European Commission, under the following conditions:

Scientific area: Health Promotion

Requirements:

- Bachelor's degree in the field of economics or life and health sciences
- Master's degree in health economics or health management
- Attendance in a degree-granting or non-degree-granting academic program
- Strong communication and writing skills in both Portuguese and English
- Willingness to work in a multidisciplinary team
- Availability to start activities in July

Preferential factors (as evidenced in the CV):

- Knowledge in health economics and methods of economic evaluation in healthcare
- Experience in the collection and analysis of quantitative data
- Previous experience in research projects related to health economic evaluation

Work plan:

- The fellow will join an international team within the scope of the EXPOSIM project, with academic and scientific experience in the field of health economics;
- The fellow will participate in systematic literature reviews on the cost of autoimmune diseases, in collaboration with the project partners;
- The fellow will be responsible for collecting and analyzing cost data related to specific autoimmune diseases within the context of the Portuguese healthcare system;
- The fellow will contribute to drafting project reports and scientific publications, being responsible for the publications related to the analyses conducted for Portugal;
- The fellow will support project management in the specific components in which ENSP is involved.

Workplace and scientific supervision: The work will be carried out at NOVA National School of Public Health, NOVA University Lisbon, under the scientific supervision of Professor Julian Perelman, with the support of Principal Research Professor Susana Viegas.

Duration of the Research Fellowship(s): the duration of the research fellowship(s) will be for 12 months, starting in 1st July of 2025. The research fellowship(s) can be renewed up to a maximum of 48 months.

Monthly maintenance allowance: The amount of the fellowship is 1309,64 €, according to the values for research fellowships awarded by NOVA in Portugal. In addition to this amount, there is the payment of personal accident insurance, the payment of voluntary social security and doctoral program fees.

Selection methods: The selection methods will be the following: Curriculum evaluation (100%). If an interview is not deemed necessary. If an interview is considered necessary, the weighting of both components will be: curriculum evaluation (70%) and interview (30%).

Composition of the selection Jury: President: Julian Perelman, 1st Member: Susana Viegas, 2nd Member: Joana Alves.

Application deadline: The call is open from 28 May, 2025 until June 12, 2025.

Application formalization: Applications must be formalized mandatorily by e-mail to gaidi@ensp.unl.pt, with the reference 932225_253 in the subject, and must include mandatorily the following documents: Curriculum Vitae, motivation letter and academic degree certificate.

The documents required for the submission of the application will only be admitted if submitted within the deadline of application.

The following documents will be requested in the contracting phase:

- a) Copy of civil and tax identification document(s) and, where applicable, social security document(s);
- b) Document proving the country of residence, residence permit or other legally equivalent document, where applicable, valid at the start date of the fellowship;
- c) Documents proving that the candidate meets the conditions required for the respective type of fellowship, namely proof of enrollment and registration in a cycle of studies or non-degree course and/or proof of academic qualifications required for the type of fellowship, if applicable.
