Bachelor Research Fellowship

The NOVA National School of Public Health, NOVA University Lisbon, has opened an offer position for 1 Research Fellowships, within the scope of the R&D project, “PARC – Partnership for the Assessment of Risks from Chemicals”, 101057014 — PARC, funded by the European Commission, under the following conditions:

Scientific area: Communication, Science Communication, Journalism, or related fields.

Requirements:

- a) Bachelor’s degree in communication sciences, Journalism, Social Communication, Marketing, or related areas;
- b) Excellent command of spoken and written English;
- c) Strong writing skills in English for diverse audiences and channels (e.g. social media, websites, newsletters);
- d) Experience in image editing (e.g. Canva, Adobe Photoshop, Illustrator) and/or video editing;
- e) Experience in content management on website back offices (e.g. WordPress, Drupal or similar);
- f) Strong organizational skills, proactivity, critical thinking, and autonomy.
- g) Frequency of course (with or without degree).

Preferential factors (optional):

- a) Previous experience in research settings or EU-funded projects.
- b) Experience in institutional, scientific, or agency-based communication.
- c) Interest and motivation to work in public health, environmental health, or chemical safety-related contexts.
- d) Immediate availability.

Work plan:

- Support research activities in the area of science communication;
- Support the creation and editing of communication content in English and Portuguese on research project results;
- Writing and editing of articles, interviews, and scientific outreach materials;
- Management of digital content (website and social media);
- Support communication strategies for projects, including planning, scheduling, and production of materials;
- Collaboration in the organization of events and science dissemination initiatives.

Workplace and scientific supervision: The work will be carried out at NOVA National School of Public Health, NOVA University Lisbon, under the scientific supervision of Professor Susana Viegas.

Duration of the Research Fellowship(s): the duration of the research fellowship will be 6 months with a planned start date in November 2025. The contract may be renewed until the end of the granted funding, not exceeding the maximum period defined in the applicable legal framework (EBIC).

Monthly maintenance allowance: The amount of the fellowship is 1040.98€, according to the values for research fellowships awarded by NOVA in Portugal. In addition to this amount, there is the payment of personal accident insurance and the payment of voluntary social security.

Selection methods: The selection methods will be the following: Curriculum evaluation (100%) in case there is no need for an interview. If an interview is considered necessary, both components will be weighted: Curriculum evaluation (70%) and interview (30%).

Application deadline: The call is open from 1 October, 2025 until 31 October, 2025.

Application formalization: Applications must be submitted by email to gaidi@ensp.unl.pt, with the reference 932203_252 in the subject line. The following documents must be attached: Curriculum Vitae, Motivation Letter, and Academic Degree Certificate.

Only applications submitted within the deadline will be considered.

The documents required for the submission of the application will only be admitted if submitted within the deadline of application.

The following documents will be requested in the contracting phase:

- a) Copy of civil and tax identification document(s) and, where applicable, social security document(s);
- b) Document proving the country of residence, residence permit or other legally equivalent document, where applicable, valid at the start date of the fellowship;
- c) Documents proving that the candidate meets the conditions required for the respective type of fellowship, namely proof of enrollment and registration in a cycle of studies or non-degree course and/or proof of academic qualifications required for the type of fellowship, if applicable.
